Some duties and responsibilities may overlap between class levels. The classification specification is not intended to provide an exhaustive list of all duties performed.

Classification Title: Audiologist

Date Updated: May 20, 2008

Job Summary:

The Audiologist is responsible for the identification, assessment and management of clients with hearing and balance (vestibular) disorders. Develops, coordinates and implements clinical and promotion/ prevention programs for all clients with hearing problems.

Key Responsibilities and Typical Duties:

Core Duties

- Screens, identifies, assesses, interprets diagnoses, prevents, and rehabilitates individuals with peripheral and central auditory system dysfunction.
- Performs a variety of standard and specialized diagnostic assessments including standard audiometry and emmittance testing, auditory processing, evoked auditory potentials, otoacustic emissions testing, balance (vestibular) assessments and tinnitus evaluations.
- Performs hearing aid evaluations and makes recommendations regarding selection and purchase of hearing aids.
- Verifies performance of amplification devices and including hearing aids, cochlear implants, and bone anchored hearing aids utilizing using a combination of behavioral and/or electroaccoustic measures.
- May develop and implement environmental and occupational hearing conservation programs.
- May perform cochlear implant candidacy assessments, device programming and verification procedures.
- Establishes appropriate intervention plans to manage/reduce the impact of hearing loss.
- May coordinate specific clinics for hearing/ balance issues.
- Provides education and consultation services to communities, physicians, hospitals and service organizations as requested.
- Selects, fits, verifies and loans amplification, assistive listening and alarming devices and other systems to clients and provides training in their use.





Other Related Duties

- Provides input into new program development and planning.
- Recommends policies, procedures and standards for program area.
- May identify areas for research and participate in ongoing research and/ or clinical trials and studies.
- Ensures appropriate equipment functioning, calibration and maintenance.
- Evaluates and recommends equipment and supply purchases.

Leadership

- Provides functional/collegial guidance to Speech Language Pathologists, Speech Language Pathology Assistants, Audiology Technicians and Audiology Assistants.
- May instruct, counsel, direct, supervise and evaluate Audiology practicum students.
- May train and supervise regional hearing screening personnel and school teachers.

Decision-Making

- Makes independent decisions regarding hearing assessment and intervention services.
- Receives and prioritizes referrals.
- Advises on various promotion and prevention program protocols.
- Recommends follow up actions to the family, school or individual client.

- Extensive standing, bending and twisting.
- Extensive computer work.
- Required to open and close heavy magnetic doors.





Work Environment

- Works in enclosed sound booths.
- Exposed to loud noises/feedback/alarms.
- Works in low/ dim light when performing evoked potentials.
- Potential exposure to bodily fluids.
- May work with aggressive clients and/or children with behavioral issues.
- Travel in all weather/road conditions.
